



## GWRHA SELECT STALLION AUCTION PROGRAM

The Great Western Reining Horse Association, Inc. (GWRHA) is a non-profit 501(c)(3) organization formed for the purpose of promoting the sport of Western Reining in the Northwest U.S. Donations to the GWRHA are considered tax deductible charitable contributions by the IRS.

The GWRHA is seeking breeding donations of select stallions to be auctioned off as a fundraising activity. The proceeds from the Select Stallion Auction benefit the annual GWRHA Best Little Derby in the West (the “Derby”) held at the Ford Idaho Horse Park in Nampa, Idaho in April. Stallion owners donating a breeding are eligible for Sire Awards. The sale of a stallion breeding makes that stallion eligible for Sire Awards for that year (e.g. an owner donates a breeding for the 2018 year, that stallion is an “Eligible Sire” for the 2018 Derby). The breeding must sell for the stallion to be an Eligible Sire and for the stallion owner to be eligible for Stallion Awards. The foal resulting from the donated breeding will be eligible for a free entry in the Level 4 Open or the Level 4 Non Pro Derby.

Of the total funds raised, 80% will be used as added money in the Derby; 10% of the proceeds are for Sire Awards; and 10% will be used to cover administrative costs. Sire Awards will be paid to the owner of the Eligible Sire of the highest scoring open horse and the highest scoring non pro horse in the Derby.

The third party (“Mare Owner”) purchasing the stallion breeding from the GWRHA will be responsible for payment of any and all charges and/or fees relating to the breeding including chute fees, booking fees, semen shipping charges, mare care, breeding facility, vet fees or any other expenses. GWRHA is not responsible for fees, costs, charges or expenses of any kind.
